

Terms & Conditions – Jet2holidays ‘Bid for a Break’ myJet2 Promotion – September Special

These promotions are promoted by Jet2holidays Limited (registered number: 04472486) whose registered office is at Low Fare Finder House, Leeds Bradford Airport, Yeadon, Leeds, West Yorkshire, LS19 7TU ("Jet2holidays" or "we"). By entering a promotion, you are deemed to accept these terms:

1. Bid For a Break myJet2 will run throughout September 2023. There will be one promotion each week which is available for myJet2 members only which will open at 00:01 on the starting date and close at 23:59 on the closing date as further detailed below in the ‘Dates’ section.
2. There will be 4 prizes available throughout the month available for myJet2 members only. Members will need to have a valid myJet2 account to enter the draw.
3. To sign up to be a myJet2 member, entrants will need to use a valid email address, verify their email address and create a password.

6. At the time of publication of these terms and conditions, it is anticipated that Jet2holidays may hold more promotions and in the event that further promotions are held, Jet2holidays shall republish these terms and conditions with updated holiday details. Jet2holidays may cancel or extend a promotion without notice at any time and is not obliged to hold any more promotions.
7. Entrants to a promotion must be residents of the UK, the Channel Islands or the Isle of Man and must be aged 18 years or over. Employees and officers of Jet2holidays, Jet2.com Limited, Jet2 plc or any companies within the same group or any organisation professionally involved with a promotion (or in each case, their close relatives) are not eligible to enter. An entrant may only be entered into a promotion once but they may enter as many promotions as they like.

How to enter:

8. To enter a promotion for an opportunity to purchase a holiday at a lowest unique bid price, you must go on the Jet2 app between the times detailed in paragraph 5 above and follow the directions to the entry page of “Bid for a Break”, where you must then log into your myJet2 account and complete the relevant form, entering the price you think will be the lowest unique bid for the holiday displayed and as detailed within these terms.
9. Jet2holidays shall not be responsible for and shall not have to accept entries which do not reach it before the closing date or are illegible, incomplete or corrupted, or cannot be submitted for any reason. You must have a valid email address to participate in a promotion.

Choosing a Winner:

10. There will be one winner of each promotion. The winner of a promotion will be either (i) the person who has entered the lowest unique bid for the advertised holiday in that promotion; or (ii), in the unlikely event of there being no lowest unique bid, Jet2holidays will take the price that has been entered by the lowest number of people and randomly select a winner from those entrants who have entered that price. Where there are two or more prices with jointly the lowest number of entrants who have bid on the respective amounts, the winner will be randomly selected from the entrants who submitted the lowest of those prices.
11. The winner will be notified by email or using the other contact details provided to us within 12 hours after the closing time for the relevant promotion. We will try our best to contact the winner during the specified time.
12. Once contact has been made with the winner, they will be offered the chance to purchase the holiday that was the subject of the particular promotion they have won and they will be required to confirm whether they would like to purchase that holiday at the price of their winning bid or not, within 24 hours of having been notified of their win. The winner is under no obligation to purchase the holiday.
13. If the winner does confirm that they would like to purchase the holiday at the winning price, Jet2holidays will take the winner through its holiday booking process, which will be subject to Jet2holidays' and Jet2.com's terms and conditions which can be found at <http://www.jet2holidays.com/terms-and-conditions> and <http://www.jet2.com/terms> respectively (together, the “Terms and Conditions”).
14.  - ix. A 7-night Indulgent Escapes holiday on a bed & breakfast basis in a double or twin room in the main building with sea view at the 5* Minos Beach Art Hotel in Crete, Greece for 2 adults; at least one of the party must be over the age of 18 at the date of departure.
 - x. The holiday includes return flights from any UK Airport from which Jet2.com flies to Crete (Heraklion) airport (HER) and allows the duration of the prize advertised.
 - xi. The prize also includes private transfers to and from the overseas airport and the hotel, a 25kg hold-baggage allowance per person on each flight and a complimentary drink per person per flight, and priority lane security pass at your outbound UK departure airport.

- xiii. A 7-night Indulgent Escapes holiday on a bed & breakfast basis in a Premier Suite with Balcony at the 5* Quinta Jardins Do Lago in Madeira, Portugal for 2 adults, 2 children (up to 12) at least one of the party must be over the age of 18 at the date of departure.
- xiv. The holiday includes return flights from any UK Airport from which Jet2.com flies to Madeira (Funchal) (FNC) and allows the duration of the prize advertised.
- xv. The prize also includes private transfers to and from the overseas airport and the hotel, a 25kg hold-baggage allowance per person on each flight and a complimentary drink per person per flight, and priority lane security pass at your outbound UK departure airport.

Prize details for the remaining promotions will be published closer to the opening time of the applicable promotion.

16. The prize, being the opportunity to purchase the holiday at the winning bid price, cannot be transferred.
17. If the holiday is purchased it will be subject to the Terms and Conditions, the Package Travel and Linked Travel Arrangements Regulations 2018 and any other applicable law. If the winner wishes to add any extras to the holiday as it is stated above, this must be done after the initial booking and any such amendment will also be subject to the Terms and Conditions, the Package Travel and Linked Travel Arrangements Regulations 2018 and any other applicable law.
18. Holidays are subject to availability. Upon booking their holiday, the winner will be required to select their preferred travel dates subject to any restrictions referred to in the applicable prize details above and Jet2holidays will endeavour to meet the winner's request, taking into account flight and hotel availability, Jet2holidays' and any applicable hotelier's operation and any other relevant factors which may affect availability.
19. Transfers to and from the airport in the UK are not included unless otherwise specified. Travel insurance is not included. Winners are advised to take out their own insurance.
20. All passengers must have a valid passport to travel, and must meet all relevant visa and/or other entry requirements including any medical/health screening requirements or similar.

General:

21. Entrants' details will be used to administer the promotion and winner's details will be used to provide the holiday (where they do wish to purchase the holiday at the winning bid price). 22. When entering a promotion, entrants will be invited to opt in to receiving marketing from Jet2holidays. If entrants choose to opt in, their details will be retained by Jet2holidays for the purposes of marketing (which may include activities such as passing on information about deals, offers and promotion codes from Jet2holidays).

23. Jet2holidays may in its absolute discretion change these terms and conditions without prior notice at its discretion.
24. If any person enters or attempts to enter a promotion in a manner which Jet2holidays determines (acting reasonably): (a) is contrary to these terms; (b) by its nature is inconsistent with the spirit of the promotion; and/or (c) is unjust to other participants, then such person may be disqualified from the promotion at Jet2holidays' sole discretion and may be required to return any prizes already awarded (if applicable). This may include without limitation participation by professional competitors, tampering with the operation of the promotion, cheating, hacking, deception or any other actions which disadvantage (or are intended to disadvantage) other participants and/or Jet2holidays. Furthermore, where Jet2holidays determines that such actions have impaired the promotion, Jet2holidays may, at its sole discretion take such steps as it deems reasonable to resolve any problems arising from such actions, including:
 - a. repeating or adding further stages to the promotion; or
 - b. in the event of disqualification, awarding the prize to another entry as per these terms and conditions.
