

Terms & Conditions – Jet2holidays ‘Bid for a Break’ September 2026

This prize draw is promoted by Jet2holidays Limited (registered number: 04472486) whose registered office is at Low Fare Finder House, Leeds Bradford Airport, Yeadon, Leeds, West Yorkshire, LS19 7TU ("Jet2holidays" or "we"). By entering the prize draw, you are deemed to accept these terms:

1. This myJet2 Bid For a Break prize draw will run for a week from the 4th September 2026 to the 11th September 2026. The prize draw will start at 10.00am on 4th September 2026 (the starting date) and close at 10:00am on 11th September 2026 (the closing date).
2. Entrants to this prize draw must be residents of the UK, the Channel Islands or the Isle of Man and must be aged 18 years or over. Employees and officers of Jet2holidays, Jet2.com Limited, Jet2 plc or any companies within the same group or any organisation professionally involved with the prize draw (or in each case, their close relatives) are not eligible to enter.
3. An entrant may only enter the prize draw once. If you enter the prize draw more than once, all entries will be removed and you will be disqualified from the prize draw.
4. The winner will have a choice of two holidays to pick from as detailed in the Prizes section below. The winner will only be able to choose one of the two options.

How to enter:

5. To enter this prize draw for an opportunity to purchase a holiday at the lowest unique bid price, you must go on the Jet2 app between the times detailed in paragraph 1 above and follow the directions to the entry page of "Bid for a Break", where you must then complete the relevant form, entering the price you think will be the lowest unique bid for the holidays displayed and as detailed within these terms.
6. Jet2holidays shall not be responsible for and shall not have to accept entries which do not reach it before the closing date or are illegible, incomplete or corrupted, or cannot be submitted for any reason. You must have a valid email address to participate in the prize draw.

Choosing a Winner:

7. There will be one winner of the prize draw. The winner of the prize draw will be either (i) the person who has entered the lowest unique bid for the advertised holidays in the prize draw; or (ii), in the unlikely event of there being no lowest unique bid, Jet2holidays will take the price that has been entered by the lowest number of people and randomly select a winner from those entrants who have entered that price. Where there are two or more prices with jointly the lowest number of entrants who have bid on the respective amounts, the winner will be randomly selected from the entrants who submitted the lowest of those prices.
8. The winner will be notified by email or using the other contact details provided to us within 48 hours after the closing time of the prize draw. We will try our best to contact the winner during the specified time.
9. Once contact has been made with the winner, they will be offered the chance to purchase one of the two holidays that were the subject of the particular prize draw they have won. They will be required to confirm whether they would like to purchase one of the holidays at the price of their winning bid or not, within 48 hours of having been notified of their win. The winner is under no obligation to purchase the holiday.
10. If the winner does confirm that they would like to purchase one of the holidays at the winning price, Jet2holidays will take the winner through its holiday booking process, which will be subject to Jet2holidays' and Jet2.com's terms and conditions which can be found at <http://www.jet2holidays.com/terms-and-conditions> and <http://www.jet2.com/terms> respectively (together, the "Terms and Conditions").
11. For the avoidance of doubt, the winner may only purchase **one** of the holidays with their winning bid. There is no option to purchase both holidays at the price of the winning bid.
12. If the winner (i) cannot be contacted or is not available; (ii) has not confirmed whether or not they would like to purchase one of the holidays at the winning price within 48 hours of having been notified of their win; or (iii) does not want to purchase either of the holidays at the winning price, then the winner will forfeit their prize and will no longer be entitled to purchase one of the holidays at the winning price. If this happens, Jet2holidays can select another winner using the same selection criteria described above.

For transparency we will generally publish the first name, first letter of surname and county of prize winners online. However, if you are a winner and you object to us doing this or would like us to reduce the amount of information we publish, then please let us know when claiming your prize.

The Prizes:

13. The Prize is the opportunity to purchase one of the following holidays at the winning bid price:

Option 1

- i. A 7-night holiday on an all-inclusive plus basis in a Family bungalow with Sliding Doors at the 4* plus Aeolos Beach Resort
- ii. in Corfu, Greece for 2 adults (over the age of 18 at the date of departure) and 2 children (up to age 12 on the date of return).
- iii. The holiday includes return flights from any UK Airport from which Jet2.com flies to Corfu Airport (CFU) and allows for the duration of the prize advertised, transfers to and from the overseas airport and the hotel AND 1 free item of checked baggage of up to 22kg per person.
- iv. If the winner opts to book, this holiday must be booked by 30th September 2026 and travel to and from the destination must be completed between one of the following bands subject to availability (including all return travel):

Option 2

- v. A 7-night holiday on a half board basis in a junior suite at the 4* Melia La Palma
- vi. in La Palma, Canaries for 2 adults (over the age of 18 at the date of departure) and 2 children (up to age 11 on the date of return).
- vii. The holiday includes return flights from any UK Airport from which Jet2.com flies to La Palma Airport (SPC) and allows for the duration of the prize advertised, transfers to and from the overseas airport and the hotel AND 1 free item of checked baggage of up to 22kg per person.
- viii. If the winner opts to book, this holiday must be booked by 30th September 2026 and travel to and from the destination must be completed between one of the following bands subject to availability (including all return travel):
 - 01/09/2026 - 22/10/2026
 - 05/11/2026 - 17/12/2026
 - 04/01/2027 - 09/02/2027
 - 22/02/2027 - 23/03/2027
 - 19/04/2027 - 28/05/2027
 - 07/06/2027 – 21/06/2027

14. The Prize, being the opportunity to purchase the holiday at the winning bid price, cannot be transferred.
15. If the holiday is purchased it will be subject to the Terms and Conditions, the Package Travel and Linked Travel Arrangements Regulations 2018 and any other applicable law. If the winner wishes to add any extras to the holiday as it is stated above, this must be done after the initial booking and any such amendment will also be subject to the Terms and Conditions, the Package Travel and Linked Travel Arrangements Regulations 2018 and any other applicable law.
16. Holidays and flights are subject to availability. Upon booking their holiday, the winner will be required to select their preferred travel dates subject to any restrictions referred to in the applicable prize details above and Jet2holidays will endeavour to meet the winner's request but this may not always be possible. Holidays and

flights are subject to availability and may be unavailable even if there is general availability on a particular flight. Jet2holidays will take into account flight and hotel availability, Jet2holidays' and any applicable hotelier's operation and any other relevant factors which may affect availability.

18. If the Prize is not booked by the applicable date, it will be deemed forfeited and Jet2holidays reserves the right to award a prize to another randomly selected entry.

General:

20. Entrants' details will be used to administer the prize draw, and winner's details will be used to provide the holiday (where they do wish to purchase the holiday at the winning bid price).
