

Terms & Conditions – Jet2holidays and B&M Prize Draw

This prize draw is promoted by Jet2holidays Limited (registered number: 04472486) whose registered office is at Low Fare Finder House, Leeds Bradford Airport, Yeadon, Leeds, West Yorkshire, LS19 7TU ("Jet2holidays"). By entering the prize draw, you are deemed to accept these terms:

1. This prize draw opens at 00.01am 2nd April 2026 and closes at 11.59pm 30th April 2026.
2. Entrants to this prize draw must be residents of the UK, the Channel Islands or the Isle of Man and must be aged 18 years or over. Employees and officers of Jet2holidays, Jet2.com Limited ("Jet2.com"), Jet2 plc, and B&M Retail Ltd or any companies within the same group or any organisation professionally involved with the prize draw (or in each case, their close relatives) are not eligible to enter. An entrant may only be entered into the prize draw once. Any attempt to enter more than once will result in those additional entries being voided.

How to enter:

3. Jet2holidays will host a landing page at www.jet2holidays.com/bm
4. To enter this prize draw you must enter your name and email address in between the times and dates detailed in paragraph 1
5. Jet2holidays shall not be responsible for and shall not have to accept entries which do not reach it before the closing time or are illegible, incomplete or corrupted.

Choosing a Winner:

6. There will be 11 lucky winners of the prize draw but prizes shall differ.
7. The winners will be randomly selected by Jet2holidays through a computer-generated process.

Jet2holidays will try its best to contact the winner during the specified time. If a winner cannot be contacted or is not available, Jet2holidays reserve the right to select another winner from the valid/correct entries that were received.
9. The winners will be required to confirm acceptance of their prize within 7 days of having been notified. If a winner has not claimed their prize by the date specified, Jet2holidays reserve the right to select another winner from the valid/correct entries that were received. The winner must have a valid email address to claim their prize.

Jet2holidays must still provide the information and winning entry to the Advertising Standards Authority on request.

The Prizes:

11. 12. Transfers to and from the airport in the UK are not included. No optional flight/board/transfer/accommodation supplements are included in the prize. Travel insurance is not included. The winner is advised to take out their own insurance. If a prize is not booked by the applicable date, it will be deemed forfeited and Jet2holidays reserves the right to award a prize to another randomly selected entry.

Jet2holidays reserves the right (but shall be under no obligation) to substitute the prize or any element of the prize with alternative dates/property/destinations/transfers/ at any time to the equivalent prize value or at its discretion, the cash value of the prize or element of the prize being substituted.

16. Jet2holidays reserves the right to amend or cancel the flights or holiday for any reason without prior notice. Please note that flight schedules are not guaranteed.

17. The prize and each element of the prize is non-transferable and may not be exchanged for cash. The prize may only be taken by the prize draw winner along with any accompanying passenger(s) notified to Jet2holidays in the relevant booking, subject to the maximum number of passengers specified within the prize details. B&M Prize Terms

24. B&M Gift Card: Each £100 B&M gift card is non-transferable, non-exchangeable and cannot be redeemed for cash. No change or refunds will be given against the card. You can check the balance at any checkout in store. The card is valid for a period of 12 months from the date of issue, and any unused balance will be lost after this date. Please protect this card and treat as cash. It cannot be replaced if lost, damaged or stolen.

General:

If entrants choose to opt in, their details will be transferred by Jet2holidays to B&M for B&M to retain for the purposes of marketing. 31. Jet2holidays may in its absolute discretion change these terms and conditions or extend the prize draw without notice at any time. Jet2holidays may cancel a prize draw without prior notice in the event of circumstances arising beyond its control.

32. Where Jet2holidays makes any changes to the prize (including dates of travel), no compensation or cash equivalent will be available. Jet2holidays will not be liable for any cancellations or changes to the prize draw or any prize, or for any loss or damage. Nothing in these terms shall exclude or limit the liability of Jet2holidays in relation to personal injury or death caused by Jet2holidays negligence or for fraud.

33.
