

Terms & Conditions – Bodrum Jet2holiday Giveaway

Entry period: 6pm on 31st July 2026 – 6pm on 6th August 2026

Entries permitted: 1

How to enter: Follow @Jet2Pics on Instagram, like the competition post and tag a friend in the comments of the post.

Number of winners: 1

Winner selection: The winner will be randomly selected through a computer-generated process.

Winner notification: The winner will be notified by Jet2holidays via Instagram Direct Message within 5 days after the closing date. The winner must accept the prize within 5 days of having been notified. If the prize is not accepted by the winner within this period, Jet2holidays will use a computer-generated process to select another winner.

Prize:

- A Jet2holidays voucher to the value of £2,000 (“the **Prize**”). The Prize must be used by the winner on a new Jet2holidays booking to Bodrum, Turkey, which for the avoidance of doubt includes standard Jet2holidays, Indulgent Escapes, Jet2Villas, VIBE and/or CityBreaks holidays.
