

Terms & Conditions – Jet2holidays Christmas Card Competition 2025

This competition is promoted by Jet2holidays Limited (registered number: 04472486) whose registered office is at Low Fare Finder House, Leeds Bradford Airport, Yeadon, Leeds, West Yorkshire, LS19 7TU ("Jet2holidays", "we" or "us"). By entering the competition, you are deemed to accept these terms:

- 1. This competition opens at 12:00pm on 1st November 2025 and closes at 12:00am on 10th November 2025.
- 2. Entrants to this competition must be residents of the UK, the Channel Islands or the Isle of Man and must be aged 18 years or over. Employees and officers of Jet2holidays, Jet2.com Limited ("Jet2.com"), Jet2 plc or any companies within the same group or any organisation professionally involved with the competition (or in each case, their close relatives) are not eligible to enter.
- An entrant may only submit one entry to the competition. Any further entries will be void.

How to enter:

- Jet2holidays will post on the Jet2.com and Jet2holidays Facebook page on the 1st November 2025 (and on other dates thereafter), outlining details of the competition.
- To enter this competition you must create a hand drawn Christmas card and send a digital photo of the Christmas card creation to ChristmasCard@jet2.com before the closing time and date detailed in paragraph 1 above.
- Jet2holidays shall not be responsible for and shall not have to accept entries which do not reach it before the closing time or are illegible, incomplete, corrupted, or do not meet the entry requirements detailed above
- Entrants must have a valid email address to claim this prize.

Choosing a Winner and Runners Up:

- There will be 1 winner of the competition and 2 runners up.
- A shortlist of the best entries will be picked by Jet2holidays and an independent judge will pick the winning entry from the shortlist based on a subjective interpretation of the those entries. The judge's decision is final and no correspondence will be entered into.

- The winner of the competition and the runners up will be notified by email or using the other contact details provided to us within 14 days after the closing time for the competition. We will try our best to contact the winner during the specified time. If a winner cannot be contacted or is not available, we reserve the right to have the judge select another winner from the valid/correct entries that were received.
- The winner and runners up will be required to confirm acceptance of their prize within 48 hours of having been notified. If a winner has not claimed their prize within the time-frame specified, we reserve the right to have the judge select

another winner from the valid/correct entries that were received. Winners must have a valid email address to claim their prize.

- For transparency we will generally publish the surname and county of competition winners online. However, if you are a winner or runner up and you object to us doing this or would like us to reduce the amount of information we publish, then please let us know when claiming your prize.

The Prizes:

- The competition winner will win a £1,000 Jet2holidays voucher.
- The runners up winners will each win a £250 Jet2holidays voucher. (collectively, **“the Vouchers”**)

- Please note, the Voucher must be used by the winner on a new Jet2holidays booking, which for the avoidance of doubt includes standard Jet2holidays, Indulgent Escapes, Jet2Villas, VIBE and/or CityBreaks holidays. It cannot be used on an existing booking.
- The winner may book more than one holiday using the voucher but if doing so, the holiday bookings must be made at the same time and can total more than the Voucher but the difference in value must be paid at the same time. The Voucher must be redeemed by 31st March 2026, and all travel must be completed by 31st March 2207. Booking must be made via the Jet2holidays contact centre.

- If the Voucher is not redeemed by the applicable date, it will be deemed forfeited.
- Where the holiday booked using the Voucher is equivalent or lower than the value of the Voucher it shall be subject to the Promotion terms and conditions and the Jet2holidays' and Jet2.com's terms and conditions (together the **"Terms and Conditions"**) which can be found at <http://www.jet2holidays.com/terms-and-conditions> and <http://www.jet2.com/terms> respectively. Such holiday shall not constitute a ‘package’ under the Package Travel and Linked Travel Arrangements Regulations 2018 (the **“Regulations”**) and the Regulations shall not apply, nor shall the applicable provisions of the Terms and Conditions which

relate to the Regulations. Where the holiday booked using the Voucher exceeds the value of the Voucher it shall be subject to the Terms and Conditions. In the event of any conflict between the Terms and Conditions and the Promotion terms and conditions, the Promotion terms and conditions will take precedence.

- The Voucher and any holiday booked using the Voucher is subject to availability. Please note, prize flights are limited on the flights operated by Jet2.com and may be unavailable even if there is general availability on a particular flight.
- Jet2holidays reserves the right to amend or cancel the flights or holiday for any reason without prior notice (which may include substituting the Voucher or any element of the Voucher with alternative dates/property/transfers/destinations at any time, to the equivalent prize value). Please note that the Jet2.com flight schedules are not guaranteed.
- The Voucher is non-transferable and may not be exchanged for cash. The winner has no right to request or receive an alternative to the Voucher, and the Voucher cannot be redeemed for cash or its monetary value, in whole or in part.
- If the total cost of the holiday that the winner selects totals less than the Voucher amount, the winner shall not be entitled to the difference and that additional amount shall be forfeited. If the winner would like to choose a holiday which totals more than the voucher amount, they shall be responsible for paying the difference in cost.
- The holiday booked using the Voucher may only be taken by the winner along with any accompanying passenger(s) notified to Jet2holidays in the relevant booking. Flights must be taken by all passengers at the same time from the same airport. Once you have made your booking this cannot be amended.

General:
