

Terms & Conditions – Jet2holidays x Millie’s Cookies Prize Draw

This prize draw is promoted by Jet2holidays Limited (registered number: 04472486) whose registered office is at Low Fare Finder House, Leeds Bradford Airport, Yeadon, Leeds, West Yorkshire, LS19 7TU ("Jet2holidays", "we" or "us"). By entering the prize draw, you are deemed to accept these terms:

1. This prize draw opens at 09:00am on 9th March 2026 and closes at 11:59pm on 9th April 2026.
2. Entrants to this prize draw must be residents of the UK, the Channel Islands or the Isle of Man and must be aged 18 years or over. Employees and officers of Jet2holidays, Jet2.com Limited ("Jet2.com"), Jet2 plc and Millie’s Cookies or any companies within the same group or any organisation professionally involved with the prize draw (or in each case, their close relatives) are not eligible to enter. An entrant may only be entered into the prize draw once.

How to enter:

3. Jet2holidays will host an entry form at www.jet2holidays.com/milliescookies
4. To enter this prize draw you must enter before the closing time and date detailed in paragraph 1 above.
5. Jet2holidays shall not be responsible for and shall not have to accept entries which do not reach it before the closing time or are illegible, incomplete or corrupted.

Choosing a Winner:

6. There will be 1 lucky winner of the prize draw.
7. The winner will be randomly selected through a computer-generated process.
8. The winner of the prize draw will be notified by the email they used to enter the prize draw within 7 working days after the closing time for the prize draw. Jet2holidays will try its best to contact the winners during the specified time. If a winner cannot be contacted or is not available, Jet2holidays reserve the right to select another winner from the valid/correct entries that were received.
9. The winner will be required to confirm acceptance of their prize within 7 working days of having been notified. If a winner has not claimed their prize by the date specified, we reserve the right to select another winner from the valid/correct entries that were received. Winners must have a valid email address to claim their prize.
10. For transparency we will generally publish the surname and county of prize winners online. However, if you are a winner and you object to us doing this or would like us to reduce the amount of information we publish, then please let us know when claiming your prize.

The Prize:

11. The winner will win two prizes:
 - £3k Jet2holidays voucher

(The “Jet2holidaysPrize” which is subject to the “Holiday Prize Terms” and the “General Terms”)

AND

- 1 x year’s supply of Millie’s Cookies

(The “Millie’s Cookies Prize” which is subject to the “Millie’s Cookies Prize Terms” and the “General Terms

Jet2holiday Prize Terms:

12. The winner will win a Jet2holidays voucher to the value of £3,000 (“the **Prize**”). Please note, it must be used by the winner on a new Jet2holidays booking, which for the avoidance of doubt includes standard Jet2holidays, Indulgent Escapes, Jet2Villas, VIBE and/or CityBreaks holidays. It cannot be used for an existing booking.
13. The winner may book more than one holiday using the voucher but if doing so, the holiday bookings must be made at the same time and can total more than the Prize but the difference in value must be paid at the same time. The voucher must be redeemed by 30th June 2026, and all travel must be completed by 31st October 2027. Booking must be made via the Jet2holidays contact centre.
14. The voucher can be used in conjunction with any money off discount which is automatically applied to bookings on www.jet2holidays.com or the Jet2holidays app (subject to the terms of that promotion) but cannot be used in conjunction with any other discount code. Optional extras may be added at the winner’s own expense. Any optional purchases or supplements are subject to the standard Jet2holidays or Jet2.com terms and conditions.
15. If any holiday booked by the winner with the Prize is cancelled for any reason and where that cancellation would entitle the customer to a refund in line with Jet2holidays’ terms and conditions, such a refund would be in the form of the payment method in which the holiday was paid for (which may be a combination of a voucher and cash).
16. Where the holiday is booked using the Prize, transfers to and from the airport in the UK are not included. Travel insurance is not included. Winners are advised to take out their own insurance.
17. If the Prize is not redeemed by the applicable date, it will be deemed forfeited.
18. Where the holiday booked using the Prize is equivalent or lower than the value of the voucher it shall be subject to the Promotion terms and conditions and the Jet2holidays’ and Jet2.com’s terms and conditions (together the “**Terms and Conditions**”) which can be found at <http://www.jet2holidays.com/terms-and-conditions> and <http://www.jet2.com/terms> respectively. Such holiday shall not constitute a ‘package’ under the Package Travel and Linked Travel Arrangements Regulations 2018 (the “**Regulations**”) and the Regulations shall not apply, nor shall the applicable provisions of the Terms and Conditions which relate to the Regulations. Where the holiday booked using the Prize exceeds the value of the voucher it shall be subject to the Terms and Conditions. In the event of any conflict between the Terms and Conditions and the Promotion terms and conditions, the Promotion terms and conditions will take precedence.
19. The Prize and any holiday booked using the Prize is subject to availability. Please note, prize flights are limited on the flights operated by Jet2.com and may be unavailable even if there is general availability on a particular flight.
20. Jet2holidays reserves the right to amend or cancel the flights or holiday for any reason without prior notice (which may include substituting the prize or any element of the prize with

alternative dates/property/transfers/destinations at any time, to the equivalent prize value). Please note that the Jet2.com flight schedules are not guaranteed.

21. The Prize is non-transferable and may not be exchanged for cash. The winner has no right to request or receive an alternative to the Prize, and the Prize cannot be redeemed for cash or its monetary value, in whole or in part.
22. If the total cost of the holiday that the winner selects totals less than voucher amount, the winner shall not be entitled to the difference and that additional amount shall be forfeited. If the winner would like to choose a holiday which totals more than the voucher amount, they shall be responsible for paying the difference in cost.
23. The holiday booked using the Prize may only be taken by the prize draw winner along with any accompanying passenger(s) notified to Jet2holidays in the relevant booking. Flights must be taken by all passengers at the same time from the same airport. Once you have made your booking this cannot be amended.
24. All passengers must have a valid passport to travel and must meet all relevant visa and/or other entry requirements including health or medical requirements or similar.

Millie's Cookies Prize Terms

25. A free year's supply of cookies entitles you to 1 box of 12 classic cookies per month for a year, for which you will receive 12 vouchers. To redeem, simply hand over your voucher at the till.
26. Your year starts when the first voucher is used and expires after 12 months. Each voucher can only be used once a month. It will be up to the winner to keep note of this usage. Only original vouchers will be accepted. Not to be used in conjunction with any other discount or vouchers.
27. Vouchers are redeemable at UK Millie's stores only (excluding Millie's franchise sites: Haven, Cove and Bury stores). Vouchers are not exchangeable for cash.
28. Defaced, torn or photocopied vouchers will not be accepted. Offer subject to availability.
29. Management reserves the right to refuse voucher. Voucher to be retained in store.

General:

30. Entrants' details will be used to administer the prize draw. Details will be used in accordance with the Jet2holidays privacy policy (see <https://www.jet2holidays.com/privacy-policy><http://www.jet2.com/privacy>).
31. When entering the Prize Draw entrants will be invited to opt in to receiving marketing from Jet2holidays. If entrants choose to opt in, their details will be retained by Jet2holidays for the purposes of marketing (which may include activities such as passing on information about deals, offers and promotion codes from Jet2holidays).
32. When entering the Prize Draw entrants will be invited to opt in to receiving marketing from Millie's Cookies. If entrants choose to opt in, their details will be passed by Jet2holidays to Millie's Cookies which Millie's Cookies will retain for the purposes of marketing. To enable us to use entries as widely as possible entrants agree that any intellectual property rights in their entries (and any accompanying material) will belong to us and entrants waive any rights they have in relation to their entry and any accompanying material. At our request entrants must sign any documents to assign the rights to us. Entrants also agree that we may decide at our discretion how their submitted material may be used from time to time (which may include entrants' photo where they have submitted one).
34. Jet2holidays may in its absolute discretion change these terms and conditions or extend the prize draw without notice at any time. Jet2holidays may cancel a prize draw without prior notice in the event of circumstances arising beyond its control.

35. Where Jet2holidays makes any changes to the prize (including dates of travel), no compensation or cash equivalent will be available. Jet2holidays will not be liable for any cancellations or changes to the prize draw or any prize, or for any loss or damage. Nothing in these terms shall exclude or limit the liability of Jet2holidays in relation to personal injury or death caused by Jet2holidays negligence or for fraud.

If any person enters or attempts to enter the prize draw in a manner which Jet2holidays determines is: (a) contrary to these terms; (b) by its nature is inconsistent with the spirit of the prize draw; and/or (c) unjust to other participants, then such person may be disqualified from the prize draw at Jet2holidays' sole discretion and may be required to return any prizes already awarded.
