

Terms & Conditions – myJet2Perks x Harvester Prize Draw

This prize draw is promoted by Jet2.com Limited (registered number: 02739537) whose registered office is at Low Fare Finder House, Leeds Bradford Airport, Yeadon, Leeds, West Yorkshire, LS19 7TU ("Jet2.com", "Jet2" "us" or "we"). By entering this prize draw, you are deemed to accept these terms.

1. This prize draw opens at 09:00 on 22nd January 2026 and closes at 23:59 on 2nd February 2026. Entrants to this prize draw must be myJet2 members logged into myJet2 on the Jet2 app, residents of the UK, the Channel Islands or the Isle of Man and must be aged 18 years or over. Employees and officers of Jet2holidays Limited, Jet2.com Limited, Jet2 plc, employees and officers of Mitchells & Butlers plc or any companies within the same group or any organisation professionally involved with the prize draw (or in each case, their close relatives) are not eligible to enter. Entrants can enter the prize draw an unlimited number of times within the campaign live period, when they have available spins to use and are not in a 'cooldown' period.

How to enter:

2. Jet2 will host a landing page in the Jet2 app.
3. To enter this prize draw you must log onto myJet2 within the Jet2 app and click to enter the prize draw by following the relevant URL and enter your details before the closing time and date detailed in paragraph 1 above.
4. Then use your email address (and optional phone number) associated with your myJet2 account to register on the "Spin for Sun" screen, which can be found on the Jet2 App homepage or myJet2Perks page. After completing the registration, you will need to spin the wheel.
5. You will be provided with three coins after registering for Spin for Sun and shall be provided with additional coins each day throughout the Promotional Period to top up the number of coins available to a total of three coins. For example, if you have one coin remaining from the previous day, you will be provided with an additional two coins the next day.
6. Entrants can gain additional coins in the following ways:
 - (a) Spinning the wheel and landing on the free coin segment (+1 coin)
 - (b) By redeeming another player's share code (+1 coin). (Information on how this works outlined below in points 7 & 8).

Choosing a winner:

10. There will be 402 lucky winners of the prize draw.
11. Following each spin of the wheel, and subject to where the wheel stops you will either win one of the prizes shown in clause 22 below or you may not win a prize.
12. There is no limit on the number of prizes that an entrant can win.
13. The winner of each prize will be randomly selected through a computer-generated process.
14. Winners must have a valid email address to claim their prize.
15. The winners of each bonus spin prize will see the amount of bonus spins instantly within the App. They will then be automatically added to the bonus spin counter in the top right.

16. The winners of the holiday prize and the Harvester gift card prizes will be notified instantly within the App.
17. Jet2's gamification data processor will pass the winners' details (of those who have won the Harvester prizes only) to Harvester and its administrator BlackHawk) in order to contact the winners and fulfil the prizes.

We will try our best to contact the winners during the specified 7 working days. This process may be completed more than once in the event the replacement winner cannot be contacted or is not available or forfeits their prize.

The winners of the Harvester prizes will be notified by Harvester or its administrator, BlackHawk, to the email address which they used to enter the prize draw or using the other contact details provided to us within 10 days after the closing time for the prize draw. Harvester/BlackHawk will try their best to contact the winners during the specified time. The winner of the £1,000 Harvester physical gift card will have 7 days to accept their prize after being emailed with the details of their win. Harvester will contact the winner of the £1,000 Harvester physical gift card prize and request their delivery address. Blackhawk, Harvester's gift card supplier, will then supply a physical gift card (zero value added whilst in delivery) to the winner's delivery address via recorded post. The prizes:

This prize includes return flights for up to 4 people (two adults, two children - up to the age of 12 on the date of return) from any UK Airport from which Jet2.com flies to Paphos Airport (PFO) and allows for the duration of the holiday advertised, transfers to and from the overseas airport and the hotel AND 1 free item of checked baggage of up to 22kg per person.

The holiday prize acceptance:

27.
