

Terms & Conditions – Jet2CityBreaks x Stonehouse Restaurants Prize Draw

This prize draw is promoted by Jet2holidays Limited (registered number: 04472486) whose registered office is at Low Fare Finder House, Leeds Bradford Airport, Yeadon, Leeds, West Yorkshire, LS19 7TU ("Jet2holidays", "we" or "us"). By entering the prize draw, you are deemed to accept these terms:

1. This prize draw opens at 00:01am on 3rd March 2026 and closes at 11.59pm on 30th April 2026.
2. Entrants to this prize draw must be residents of the UK, the Channel Islands or the Isle of Man and must be aged 18 years or over. Employees and officers of Jet2holidays, Jet2.com Limited ("Jet2.com"), Jet2 plc, and Mitchells & Butlers plc or any companies within the same group or any organisation professionally involved with the prize draw (or in each case, their close relatives) are not eligible to enter. An entrant may only be entered into the prize draw once.

How to enter:

Choosing a Winner:

10. For transparency we will generally publish the surname and county of prize winners online. However, if you are a winner and you object to us doing this or would like us to reduce the amount of information we publish, then please let us know when claiming your prize.

The Prize:

The winner will win:

- A £1,000 Jet2CityBreaks voucher, which must be booked by 31st May 2026 and all travel completed by 31st October 2027 ("Holiday Prize Terms" and "General Terms" apply); and
- A £100 Stonehouse Restaurants Digital Gift Card. ("Gift Card Terms" and "General Terms" apply).

Holiday Prize Terms:

11. The winner will win a Jet2CityBreaks voucher to the value of £1,000. Please note, it must be used by the winner on a new Jet2CityBreaks booking, which for the avoidance of doubt does not include standard Jet2holidays, Indulgent Escapes, Jet2Villas, and/or VIBE. Please note that the Jet2.com flight schedules are not guaranteed.

31. The Gift Card cannot be used (i) to make any online purchase (ii) at any Mitchells & Butlers franchise or (iii) at any site not managed by Mitchells & Butlers: please check with your server that the Gift Card can be used at the particular site before ordering.
32. SMS and email Gift Cards should be treated as cash. If deleted, they will not be re-sent.
33. SMS and email Gift Cards will be free to receive. Digital Gift Cards are valid either presented on a smart phone or printed out.
34. Gift cards can be used multiple times until all of the remaining balance is spent.
