

## **Terms & Conditions – myJet2Perks x De Vere Prize Draw**

This prize draw is promoted by Jet2.com Limited (registered number: 02739537) whose registered office is at Low Fare Finder House, Leeds Bradford Airport, Yeadon, Leeds, West Yorkshire, LS19 7TU ("Jet2.com", "Jet2" "us" or "we"). By entering this prize draw, you are deemed to accept these terms.

1. This prize draw opens at 09:00am on 5<sup>th</sup> February 2026 and closes at 11:59pm on 19<sup>th</sup> February 2026.
2. Entrants to this prize draw must be myJet2 members logged into myJet2 on the Jet2 app, residents of the UK, the Channel Islands or the Isle of Man and must be aged 18 years or over. Employees and officers of Jet2holidays Limited, Jet2.com Limited, Jet2 plc, employees and officers of De Vere and The Grand Hotel Birmingham or any companies within the same group or any organisation professionally involved with the prize draw (or in each case, their close relatives) are not eligible to enter. 3. Jet2 will host a landing page in the Jet2 app.

General Terms:
