

## **Terms & Conditions – myJet2Perks Tripp Prize Draw**

This prize draw is promoted by Jet2.com Limited (registered number: 02739537) whose registered office is at Low Fare Finder House, Leeds Bradford Airport, Yeadon, Leeds, West Yorkshire, LS19 7TU ("Jet2.com", "Jet2" "us" or "we"). By entering this prize draw, you are deemed to accept these terms.

1. This prize draw opens at 09:00am on 21<sup>st</sup> May 2026 and closes at 11:59pm on 28<sup>th</sup> May 2026.
2. Entrants to this prize draw must be myJet2 members logged into myJet2 on the Jet2 app, residents of the UK, the Channel Islands or the Isle of Man and must be aged 18 years or over. Employees and officers of Jet2holidays Limited, Jet2.com Limited, Jet2 plc, employees and officers of Tripp Ltd or any companies within the same group or any organisation professionally involved with the prize draw (or in each case, their close relatives) are not eligible to enter. Entrants can enter the prize draw an unlimited number of times within the campaign live period, when they have available coins to use.

### How to enter:

3. Jet2 will host a landing page in the Jet2 app.
4. To enter this prize draw you must log onto myJet2 within the Jet2 app and click to enter the prize draw by following the relevant URL and enter your details before the closing time and date detailed in paragraph 1 above.
5. Then use your email address (and optional phone number) associated with your myJet2 account to register on the "Spin for Sun" screen, which can be found on the Jet2 App homepage or myJet2Perks page. After completing the registration, you will need to spin the wheel. One coin will be used each time you spin the wheel.
6. You will be provided with three coins after registering for Spin for Sun and shall be provided with additional coins each day throughout the Promotional Period to top up the number of coins available to a total of three coins. For example, if you have one coin remaining from the previous day, you will be provided with an additional two coins the next day.
7. Entrants can gain additional coins in the following ways:
  - (a) Spinning the wheel and landing on the free coin segment (+1 coin)
  - (b) By redeeming another player's share code (+1 coin). (Information on how this works outlined below in points 8 & 9 below).
  - (c) By another player redeeming your share code (+3 coins) (Information on how this works outlined below in points 8 & 9).
8. Each entrant will have a unique share code displayed alongside the cooldown timer found in the 'Share' function. The cooldown timer indicates the countdown until the next day when an entrant's coins are topped up (as outlined in point 6 above). ### Choosing a Winner:

12. Following each spin of the wheel, and subject to where the wheel stops you will either win one of the prizes shown at section 23 below or you may not win a prize.

14. The winners will be randomly selected through a computer-generated process.

16. The winners of each bonus spin prize will see the amount of bonus spins instantly within the App. They will then be automatically added to the bonus spin counter in the top right.
17. The winners of all prizes (provided by Jet2 and Tripp) will be notified instantly within the App.
18. Jet2 will pass the winners' details (of those who have won the Tripp prizes only) to Tripp in order to contact the winners and fulfil the prizes.

However, if you are a winner and you object to us doing this or would like us to reduce the amount of information we publish, then please let us know when claiming your prize.

#### The Holiday Voucher Prize Acceptance:

24. The Holiday Voucher Prize Terms:

31. Jet2 reserves the right (but shall be under no obligation) to substitute the prize or any element of the prize with an alternative at any time to the equivalent prize value or at its discretion, the cash value of the prize or element of the prize being substituted.
32. The prize and each element of the prize is non-transferable and may not be exchanged for cash.

33. No element of the prize may be changed by the winner.

General Terms:

37. Where Jet2 makes any changes to the prize, no compensation or cash equivalent will be available. Jet2 will not be liable for any cancellations or changes to the prize draw or any prize, or for any loss or damage. Nothing in these terms shall exclude or limit the liability of Jet2 in relation to personal injury or death caused by Jet2 negligence or for fraud.
