

Terms & Conditions – Jet2holidays ‘Bid for a Break’ Promotions

These promotions are promoted by Jet2holidays Limited (registered number: 04472486) whose registered office is at Low Fare Finder House, Leeds Bradford Airport, Yeadon, Leeds, West Yorkshire, LS19 7TU ("Jet2holidays" or "we"). By entering a promotion, you are deemed to accept these terms:

1. Each promotion opens at 09.00 on a Monday and closes at midday on the Thursday of that week as further detailed below in the 'Prizes' section, except for the promotions occurring during the weeks with a Bank Holiday Monday. On those weeks, the promotions will begin at 09.00 on the Tuesday of that week and any attempt to enter on a Bank Holiday Monday will not be counted. At the time of publication of these terms and conditions, it is anticipated that Jet2holidays may hold more promotions and in the event that further promotions are held, Jet2holidays shall republish these terms and conditions with updated holiday details. Jet2holidays may cancel or extend a promotion without notice at any time and is not obliged to hold any more promotions.
2. Entrants to a promotion must be residents of the UK, the Channel Islands or the Isle of Man and must be aged 18 years or over. Employees and officers of Jet2holidays, Jet2.com Limited, Jet2 plc or any companies within the same group or any organisation professionally involved with a promotion (or in each case, their close relatives) are not eligible to enter. An entrant may only be entered into a promotion once but they may enter as many promotions as they like.

How to enter:

3. To enter a promotion for an opportunity to purchase a holiday at a lowest unique bid price, you must go on the Jet2holidays app between the times detailed in paragraph 1 above and follow the directions to the entry page of "Bid for a Break", where you must then complete the relevant form, entering the price you think will be the lowest unique bid for the holiday displayed and as detailed within these terms.
4. Jet2holidays shall not be responsible for and shall not have to accept entries which do not reach it before the closing date or are illegible, incomplete or corrupted, or cannot be submitted for any reason. You must have a valid email address to participate in a promotion.

Choosing a Winner:

5. There will be one winner of each promotion. The winner of a promotion will be either (i) the person who has entered the lowest unique bid for the advertised holiday in that promotion; or (ii), in the unlikely event of there being no lowest unique bid, Jet2holidays will take the price that has been entered by the lowest number of people and randomly select a winner from those entrants who have entered that price. Where there are two or more prices with jointly the lowest number of entrants who have bid on the respective amounts, the winner will be randomly selected from the entrants who submitted the lowest of those prices.
6. The winner will be notified by email or using the other contact details provided to us within 2 hours after the closing time for the relevant promotion. We will try our best to contact the winner during the specified time.
7. Once contact has been made with the winner, they will be offered the chance to purchase the holiday that was the subject of the particular promotion they have won and they will be required to confirm whether they would like to purchase that holiday at the price of their winning bid or not, within 24 hours of having been notified of their win. The winner is under no obligation to purchase the holiday.
8. If the winner does confirm that they would like to purchase the holiday at the winning price, Jet2holidays will take the winner through its holiday booking process, which will be subject to Jet2holidays' and Jet2.com's terms and conditions which can be found at <http://www.jet2holidays.com/terms-and-conditions> and <http://www.jet2.com/terms> respectively (together, the "Terms and Conditions").
9.  - xiii) A 7-night holiday on an All-Inclusive basis in a Family Room at the 4* plus Tivoli Alvor Algarve Resort & Slide & Splash Waterpark in The Algarve, Portugal for 2 adults and 2 children (up to 12 years); at least one of the party must be over the age of 18 at the date of departure.
 - xiv) The holiday includes return flights for 4 people from any UK Airport from which Jet2.com flies to Faro (The Algarve) airport (FAO) and allows the duration of the prize advertised, transfers to and from the overseas airport and the hotel AND 1 free item of checked baggage of up to 22kg per person.

- xv) If the winner opts to book, this holiday must be booked by 13th July 2023 and travel to and from the destination must be completed between one of the following bands subject to availability (including all return travel):

11. The prize, being the opportunity to purchase the holiday at the winning bid price, cannot be transferred.

If the winner wishes to add any extras to the holiday as it is stated above, this must be done after the initial booking and any such amendment will also be subject to the Terms and Conditions, the Package Travel and Linked Travel Arrangements Regulations 2018 and any other applicable law.
13. Holidays are subject to availability. 15. All passengers must have a valid passport to travel, and must meet all relevant visa and/or other entry requirements including any medical/health screening requirements or similar.

Unsuccessful Bids

16. If you are not the winner of a promotion, Jet2holidays may send you a discount code for £60 off a Jet2holidays booking via email. If Jet2holidays does send you such a code, the discount will be subject to the terms and conditions contained within that email.

General:

If entrants choose to opt in, their details will be retained by Jet2holidays for the purposes of marketing (which may include activities such as passing on information about deals, offers and promotion codes from Jet2holidays).
19. Jet2holidays may in its absolute discretion change these terms and conditions without prior notice at its discretion.
20. If any person enters or attempts to enter a promotion in a manner which Jet2holidays determines (acting reasonably): (a) is contrary to these terms; (b) by its nature is inconsistent with the spirit of the promotion; and/or (c) is unjust to other participants, then such person may be disqualified from the promotion at Jet2holidays' sole discretion and may be required to return any prizes already awarded (if applicable). This may include without limitation participation by professional competitors, tampering with the operation of the promotion, cheating, hacking, deception or any other actions which disadvantage (or are intended to disadvantage) other participants and/or Jet2holidays. Furthermore, where Jet2holidays determines that such actions have impaired the promotion, Jet2holidays may, at its sole discretion take such steps as it deems reasonable to resolve any problems arising from such actions, including:
- (a) repeating or adding further stages to the promotion; or
 - (b) in the event of disqualification, awarding the prize to another entry as per these terms and conditions.
