

Terms & Conditions – Jet2holidays and B&M employees Prize Draw

This prize draw is promoted by Jet2holidays Limited (registered number: 04472486) whose registered office is at Low Fare Finder House, Leeds Bradford Airport, Yeadon, Leeds, West Yorkshire, LS19 7TU ("Jet2holidays", "we" or "us"). By entering the prize draw, you are deemed to accept these terms:

1. This prize draw opens at 15:00pm 16th February 2024 and closes 11.59pm 12th March 2024.
2. Entrants to this prize draw must be residents of the UK, the Channel Islands or the Isle of Man and must be aged 18 years or over. This prize draw is open to current employees of B&M only and not be in their notice period, on sick leave or subject to disciplinary action. An entrant may only be entered into the prize draw once. Any attempt to enter more than once will result in additional entries being voided.

How to enter:

3. Jet2holidays will host a landing page at www.jet2holidays.com/bmemployees
4. To enter this prize draw you must enter your full name and personal email address in between the times and dates detailed in paragraph 1
5. Jet2holidays shall not be responsible for and shall not have to accept entries which do not reach it before the closing time or are illegible, incomplete or corrupted.

Choosing a Winner:

6. There will be 1 lucky winner of the prize draw.
7. The winner(s) will be randomly selected through a computer-generated process.
8. The winners of the prize draw will be notified by the email they used to enter the prize draw within 7 days after the closing time for the prize draw. Jet2holidays will try its best to contact the winners during the specified time. If a winner cannot be contacted or is not available, or is not an employee of B&M, Jet2holidays reserve the right to select another winner from the valid/correct entries that were received.
9. The winners will be required to confirm acceptance of their prize within 7 days of having been notified. If a winner has not claimed their prize by the date specified, Jet2holidays reserve the right to select another winner from the valid/correct entries that were received. Winners must have a valid email address to claim their prize. Jet2holidays shall share the winner's details with B&M in order to verify that an entrant meets the entry requirements.
10. For transparency Jet2holidays will generally publish the surname and county of prize winners online. However, if you are a winner and you object to us doing this or would like us to reduce the amount of information we publish, then please let us know when claiming your prize. Jet2holidays must still provide the information and winning entry to the Advertising Standards Authority on request.

The Prize:

The winner will win a voucher to the value of £1,000 (“the **Prize**”) for a Jet2holiday. Please note, it must be used by the winner on a new Jet2holidays booking, which for the avoidance of doubt includes standard Jet2holidays, Indulgent Escapes, Jet2Villas, VIBE and CityBreaks holidays. It cannot be used on an existing booking.

The Winner may book more than one holiday using the voucher but if doing so, the holiday bookings must be made at the same time. The holidays can total more than the value of the Prize but the difference in value must be paid by the winner at the same time. The holiday(s) booked using the voucher must be booked by **31st May 2024**, and all travel must be completed by **31st October 2025**.

Once any holiday is booked, extras may be added at the winner’s own expense. Any optional purchases or supplements are subject to the standard Jet2holidays or Jet2.com terms and conditions.

If any holiday booked by the winner with the Prize is cancelled for any reason and where that cancellation would entitle the customer to a refund in line with Jet2holidays’ terms and conditions, such a refund would be in the form of the payment method in which the holiday was paid for (which may be a combination of a credit in the form of a voucher and cash).

Where the holiday is booked using the Prize, transfers to and from the airport in the UK are not included. Travel insurance is not included. Winners are advised to take out their own insurance.

If the Prize is not redeemed by the applicable date, it will be deemed forfeited. Any amount spent using the prize must be used in one go. Any amount not used in that instance will be forfeited.

Where the holiday booked using the Prize is equivalent or lower than the £1,000, it shall be subject to these terms and conditions and the Jet2holidays’ and Jet2.com’s terms and conditions (together the “**Terms and Conditions**”) which can be found at <http://www.jet2holidays.com/terms-and-conditions> and <http://www.jet2.com/terms> respectively. Such holiday shall not constitute a ‘package’ under the Package Travel and Linked Travel Arrangements Regulations 2018 (the “**Regulations**”) and the Regulations shall not apply, nor shall the applicable provisions of the Terms and Conditions which relate to the Regulations. Suitable reassurances are provided within our general Holiday Terms, including replacing the holiday with one of equal or higher value. Winner(s) are also provided with an ATOL certificate. Where the holiday booked using the Prize exceeds the value of the £1,000 it shall be subject to the Terms and Conditions. In the event of any conflict between the Terms and Conditions and the Promotion terms and conditions, the Promotion terms and conditions will take precedence.

The Prize and any holiday booked using the Prize is subject to availability. Please note, prize flights are limited on the flights operated by Jet2.com and may be unavailable even if there is general availability on a particular flight.

Jet2holidays reserves the right to amend or cancel the flights or holiday for any reason without prior notice (which may include substituting the prize or any element of the holiday(s) booked using the prize with alternative dates/property/transfers/destinations at any time, to the equivalent prize value). Jet2holidays shall re-arrange a prize with the prize winner.

Please note that the Jet2.com flight schedules are not guaranteed.

The Prize is non-transferable and may not be exchanged for cash. The holiday booked using the Prize may only be taken by the prize draw winner along with any accompanying passenger(s) notified to Jet2holidays in the relevant booking. Flights must be taken by all passengers at the same time from the same airport. Once you have made your booking this cannot be amended.

All passengers must have a valid passport to travel, and must meet all relevant visa and/or other entry requirements including health or medical requirements or similar.

Entrants' details will be used to administer Prize redemption. Details will be used in accordance with the Jet2holidays privacy policy (see <https://www.jet2holidays.com/privacy-policy>).

Where Jet2holidays makes any changes to a booked holiday or dates of travel, no compensation or cash equivalent will be available. Jet2holidays will not be liable for any cancellations or changes to the Prize draw, or for any loss or damage entrants or accompanying passengers suffer as a result of entering the Prize draw provided that nothing in these terms shall exclude or limit the liability of Jet2holidays in relation to personal injury or death caused by Jet2holidays negligence or for fraud.

General:

11. Entrants' details will be used to administer the prize draw. Details will be used in accordance with the Jet2holidays privacy policy (see <https://www.jet2holidays.com/privacy-policy><http://www.jet2.com/privacy>).
12. When entering the Prize Draw entrants will be invited to opt in to receiving marketing from Jet2holidays. If entrants choose to opt in, their details will be retained by Jet2holidays for the purposes of marketing (which may include activities such as passing on information about deals, offers and promotion codes from Jet2holidays).
13. Jet2holidays may in its absolute discretion change these terms and conditions or extend the prize draw without notice at any time. Jet2holidays may cancel a prize draw without prior notice in the event of circumstances arising beyond its control..
14. If any person enters or attempts to enter the prize draw in a manner which Jet2holidays determines is: (a) contrary to these terms; (b) by its nature is inconsistent with the spirit of the prize draw; and/or (c) unjust to other participants, then such person may be disqualified from the prize draw at Jet2holidays' sole discretion and may be required to return any prizes already awarded. This may include without limitation participation by professional competitors, tampering with the operation of the prize draw, cheating, hacking, deception or any other actions which disadvantage (or are intended to

disadvantage) other participants and/or Jet2holidays. Where Jet2holidays determines that any actions have impaired the prize draw, Jet2holidays may, at its sole discretion take such steps as it deems reasonable to resolve any problems arising from such actions, including:

(a) repeating or adding further stages to the prize draw; or

(b) in the event of disqualification, awarding the prize to a/other runner(s) up, another entry drawn at random or the next entry with the highest number of votes (as applicable).
