Terms & Conditions - Jet2holidays Late Summer Social Competition

The Competition (as defined below) is promoted by Jet2holidays Limited (registered number: 04472486) whose registered office is at Low Fare Finder House, Leeds Bradford Airport, Yeadon, Leeds, West Yorkshire, LS19 7TU ("Jet2holidays" or "we"). By entering a Competition, you are deemed to accept these terms:

- 2. Entry to this Competition opens at midday on 19th August 2022 and closes at midday on 5th September 2022
- 3. Entrants to this Competition must be residents of the UK, the Channel Islands or the Isle of Man and must be aged 18 years or over. - 4. Jet2holidays will host the Competition on the Competition Website.

Choosing a Winner

- (c) Tickets to the Late Summer Social Gala Event on Sunday 25th September 2022 at the L'Azure hotel, entry fees to attractions and a selection of food and drink (when the attraction takes place at the named accommodation 'L'Azure hotel') will be provided. Children are available to attend.
- 16. Where the preferred airport cannot be given, we will allocate the next available (in distance order). Winners living more than 60mins from allocated airport (according to Google Maps) will be offered travel and airport accommodation the night before the flight
- 17. Unless otherwise stated at paragraph 16 above, transfers to and from the airport in the UK are not included.
